## Plan Summary [2021-22]

### General Information

A description of the LEA, its schools, and its students.

Eagle Peak Montessori has been serving students for 20 years. We have grown from 60 students in the fall of 2001 to 325 students as we went into the fall of 2020. We are located within the Mt. Diablo School District, specifically in a suburban area of Walnut Creek. We meet the common core standards through implementing the Montessori curriculum and pedagogical philosophy. All of our teachers are expected to be both Montessori credentialed as well as hold a California teaching credential.

Our student body is 16% Hispanic, 13% Asian, 2% African American, 21% Multiple ethnicities, and 45% White. 10% of our students qualify as unduplicated. 2% of our students qualify as English Language Learners and represent 5 different home languages. We do not have any one language that represents the native language of our students who qualify in this category.

### Reflections: Successes

As reflected on the California School Dashboard, our CAASSP scores continued to rise throughout the three years of data collection. We started in the Green in English Language Arts and in the Yellow for Math. We came out of 2019 with both areas in the Green and with both the average scores in both areas above the mean for the state. The first year of the Dashboard the school was new to the system and did not get their local indicator data submitted, but as reflected in the second and third year of the system, that information was successfully updated and was a closer reflection of the school's program.

During the 2020-2021 academic year we were able to maintain a consistent, cohesive, and collaborative program of instruction through Distance Learning. Our participation rate across grade levels did not drop below 98% for any period. Our teacher used a variety of asynchronous and synchronous opportunities to provide a quality program to our students.

## Reflections: Identified Need

Eagle Peak Montessori's CAASPP scores from 2019, brought the school into the Green on the Dashboard in both ELA and MATH. While moving from Yellow into Green for MATH was an accomplishment, we want to ensure that our students continue on the upward trajectory. The pandemic and Covid closures have impacted students across the globe and we cannot assume that Eagle Peak students were not impacted academically as well. On campus we administer the Renaissance Star Test to determine growth in our students academically. The Longitudinal Data for Math indicates that we either maintained or reduced the number in all grades who were in need of urgent intervention. However, there was a slight increase in both the number of students who need a lesser level of intervention and who are considered "on watch". For ELA all our elementary grades saw increases in percentage of mastery, yet our middle school students saw slight declines. The reading pull out program is usually reserved for the elementary and more emergent readers, but through this plan we will increase reading support in grades 6, 7, and 8 as well. Unfortunately, we do not have scores which are disseminated by other subgroups due to the small number of students in any classification other than White. Reducing the data to those groupings could potentially identify individual students.

The 2021-2022 academic year will be a rebuilding year. A year of returning to in person programs, reestablishing routines, reconfirming relationships with students, parents, and teachers. We will concentrate on what is working well and build on those programs. We will retain some of what was learned during Distance Learning. We are excited to reconvene and rejuvenate our public Montessori program and re-engage our community.

# Stakeholder Engagement

Each year we do an annual survey of the parents. There are questions designed to elicit parent input on the overarching goals set forth in the LCAP. For the first time in 2021, we have added a student survey as well. We held a public meeting for discussion and input prior to voting on the LCAP.

The staff is also involved in conversations about programs and improvement. As a staff we discuss data and how to better serve students who need the extra help. The curriculum advisor and I work through program options as well. Our curriculum advisor works with administration and teaching staff. We then hold a public meeting so that parents can hear about the plan and have an opportunity to ask questions about the plan.

A summary of the feedback provided by specific stakeholder groups.

In regards to two of our three goals which are directly related to instruction: 88% of parents who responded to the survey agree that Eagle Peak meets this goal of promoting academic excellence and over 90% of the parents responding feel that Eagle Peak helps their child to develop the attributes of a successful learner. Parents in open ended questions often commented on their support for the individualization of the educational program and for the way the classrooms build independence in students.

The students indicated support for several of the online applications we added during Distance Learning. We plan to utilize some of those as we return to the classrooms. It was also rewarding to see so many students who enjoy math and we want to encourage this love of math. Of course there were the normal comments about recess and time with friends. It will be important for us to remember include ample opportunities for collaboration between students and times for the them to connect.

Our teachers have explored professional development both through the school and independently that support the goals of the LCAP and bring back information and ideas from those training opportunities. However, the teachers also feel that we need to work to support more of the social/emotional needs as well as the academic needs of our students. This will help to provide them with the space they need to also be academically successful.

We listened to the feedback about some of the applications that the students felt were beneficial during Distance Learning, such as EPIC and Learning Ally. We also know that the parents support the individualized aspect of our instruction and so will continue to seek out curricular opportunities specifically in the seventh and eighth grade classrooms to bring that into the classroom. Illustrated Math is one such curriculum. We also support the individualized progress of our students by having additional staffing to help those who need more support in reading. Our elementary program has that built into the Montessori curriculum. The teachers want to hold on to certain aspects of the technology platforms to utilize for reteaching as well as for students who might miss school. We plan to incorporate these areas.

For example, if an LEA determines that low-income students have a significantly lower attendance rate than the attendance rate for all students, it might justify LEA-wide or schoolwide actions to address this area of need in the following way:

After assessing the needs, conditions, and circumstances of our low-income students, we learned that the attendance rate of our low-income students is 7% lower than the attendance rate for all students. (Needs, Conditions, Circumstances [Principally Directed])

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school

climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action(s))

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100% attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])

**COEs and Charter Schools:** Describe how actions included as contributing to meeting the increased or improved services requirement on an LEA-wide basis are principally directed to and effective in meeting its goals for unduplicated pupils in the state and any local priorities as described above.
