


Budget Overview for the 2023-24 School Year



The text description for the above chart is as follows: The total revenue projected for Eagle Peak Montessori School is \$3,468,840, of which \$3,023,608 is Local Control Funding Formula (LCFF), \$301402 is other state funds, \$143830 is local funds, and \$ is federal funds. Of the \$3,023,608 in LCFF Funds, \$66708 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

As a small independent charter school located in Walnut Creek, Eagle Peak Montessori is a passionate and committed community which has been serving students for the past 23 years. The commitment is shared amongst not only staff and board, but the parents and students as well. EPMS started out sixteen years ago, with 2 classrooms and 60 students. In that time we have grown slowly, steadily and with purpose, to 7 classrooms and an anticipated enrollment of almost 300 students. In addition to the number of students, the range of grades has increased to where we now serve grades 1 through 8. We are located within the Mt. Diablo School District, specifically in a suburban area of Walnut Creek. MDUSD is also our authorizer. We are unique in being both an Independent Charter and Indirectly funded. This means that we have a close working relationship with the district and we are grateful for that relationship.

While our students are drawn from a wide range of neighborhoods and local cities, we continue to strive for more diversification. Within our population of students, we serve 3% English Language Learners and 9% socio-economically disadvantaged. Through our educational model, we serve students on plans that are as individualized as possible. Our students are grouped in multi-age classrooms, which allow students to move through the curriculum at their own pace.

Reflections: Successes

One of the largest successes from 2021-2022 statewide testing as reported through the 2022 Dashboard status, demonstrated through the state-level assessment data is that none of our English Language Learners scored below the standard in either Math or

English/Lanugage/Arts. Our school as a whole received a HIGH for Math and a VERY HIGH for English Language Arts (ELA). We met the standard for all of the local indicators. We also have a very low suspension rate which is positive.

Reflections: Identified Need

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

The largest change on the Dashboard for Eagle Peak was our attendance. We received a LOW due to chronic absenteeism. However, we know that this was due to strict illness policies and the fact that we were still quarantining for up to 10 days, and many students missed a large number of days. We look to improve this in the 2022-2023 academic year through parent education surrounding what constitutes chronic absenteeism and how they can help keep their child in school. While our ELL students did not score below standard on any test, our Hispanic students did. We saw a discrepancy between the Hispanic and other subgroups. We are looking at our curriculum and checking it to see if there is bias in our approach that could potentially impact these scores.

Throughout 2023-2024 we will move forward with the goals we created. We will continue with the newly implemented math program and we will be continuing to provide professional development for the 7th/8th grade math teachers on the new program, Mid School Math. We will continue with the additional reading support, homework club, and initiatives to re-engage our families with classroom and campus activities. We are also planning to increase the reading support to all grade levels. We have also been able to continue with providing a counselor to support our students mental and emotional health.

Each year we do an annual survey of the parents. There are questions designed to elicit parent input on the overarching goals set forth in the LCAP.

We held a public meeting for discussion and input prior to voting on the LCAP.

Staff: the staff reviewed the LCAP goals at staff meetings.

A summary of the feedback provided by specific educational partners.

In regards to two of our three goals which are directly related to instruction:88.24% of parents (up from 79%) of parents who responded to the survey agree that Eagle Peak meets this goal of promoting academic excellence and 91% of the parents responding feel that Eagle Peak helps their child to develop the attributes of a successful learner. Parents in open-ended questions often commented on their support for the individualization of the educational program and for the way the classrooms build independence in students. Over 82 % of families feel valued by the school and community.

Our teachers reviewed the goals for the LCAP and agreed that the goals were still relevant. However, we will use the 2023-2024 academic year to explore alternative reading assessments for those students who have attained a higher level of reading.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

We listened to the feedback about some of the applications that the students felt were beneficial during Distance Learning, such as EPIC and Learning Ally. We also support the individualized progress of our students by having additional staffing to help those who need more support in reading. We will be adding reading support for grades 4-6 in additional to grades 1-3. As mentioned above, we brought in a counselor during the 2021-2022 school year through ELO funding, however, the teachers and parents showed such strong support for the position, we are continuing forward with it for 2022-2023 and will continue throughout 2023-2024 through the LCAP.

We believe that students work best when working at a pace that fits them both academically and social/emotionally. Therefore, we look for additions to our program that provide individualized support.

We moved forward with the training and implementation of the Mid-School Math as well as allowing student access to learning ally at home and at school. This was the plan and it was fully implemented.

We were unable to hire a reading specialist after our original instructor was reassigned to an assistant position. However, the scores indicate the essential role it is for the school to have a reading pullout specialist.

Eagle Peak Montessori School provides an environment where students develop deeply held values of independence, responsibility, selfrespect, respect for others and compassion. This results in self- confidence which seeps into their academic progress. When a student feels confident they are willing to try challenging lessons and work. Often students need smaller instructional settings or even time outside of the school day to accomplish this. We will provide reading support staff as well as "homework club" after school hours run by credentialed teachers.

We recognized that social/emotional and mental well being were crucial for students in order to be able to learn. The counseling position will support students with these needs. Academically, in looking at the needs of our ELL and low-income students reading/language arts and math were areas that majority of these students would benefit from the support we are planning to provide. The individualized work, and extra time and support in small groups and outside of the school day will benefit these students. We also aim to provide opportunities that would be available to their parents to participate in school partnerships as well. However, these actions must be applied school wide due to the small percentage of students who qualify under the definitions of foster youth, English learners, and low-income. If we specified actions to these groups, students could be easily identified as to this categorization.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

We are increasing the time and availability for reading support. We are adding the homework club for students and hope to expand it from 7th and 8th to all upper elementary grades eventually. The students will also benefit from teacher professional development through the techniques or information the teachers receive.
